Chair's update

It is both an honour and a privilege to be writing my first Connector article as your new Chair.

I have served on the NZPM board for four and a half years, since being so warmly welcomed in November 2018 as an Appointed Director. I appreciate the full support of my fellow directors for my recent move into the Chair role.

The Board was very saddened by the passing of Chair John DeBernardo on 18 April 2023. John was very passionate about the industry and the NZPM Co-operative, and we will deeply miss his hard work and dedication.

Mark Whitehead has advised the Board that he will be retiring at the end of his term in August 2023, and is not offering himself for re-election. I want to sincerely thank Mark for the 11 years of loyal service he has provided to NZPM, including his time as Chair of the Remuneration Committee.

We will therefore have two board vacancies for new directors to fill at the next election. I wish to reiterate the very important governance viewpoints outlined by John DeBernardo in the two-part Connector articles in <u>October</u> and <u>December 2022</u> for shareholders and potential future directors to consider when electing new directors. In summary, the articles suggest that potential directors should carefully consider their readiness for a director role on the NZPM board before standing for election. Some key matters to think about include governance training and education; governance experience through the NZPM Future Governance Programme and other organisations; level of financial literacy; and sufficient time/capacity to commit to fulfilling director duties.

We are also commencing the Future Governance appointment process. If you are interested in participating in this programme, please have a read of the Future Governance article in this edition of Connector. As outlined in the February 2023 Connector, this is now a two-year programme. The Future Governance Programme is a great starting point to learn how the Board of your co-operative works, together with developing the fundamentals of governance and the opportunity to undertake some funded external training. That external training includes the Institute of Directors' Governance Essentials series of courses, and we expect our programme appointees to commence with these as a pre-requisite to joining the programme.

I attended the NZ Plumbing Awards in early May and enjoyed meeting a number of our NZPM Shareholders, including those who won awards during the evening.

I also attended the annual NZPM Managers Conference and awards evening in May. What a dedicated, hardworking and great bunch of individuals they are! I gained a fresh appreciation for the tangible value our people place on service excellence. They are all focused on bringing their best self to work each day and thrive on both challenges and opportunities.

As Rob outlines in his CEO article, we are seeing the signs of challenging economic conditions ahead. You can be assured that along with the management team, the Board is closely monitoring our financial and cash position, costs are being well managed, and our property and technology investments are moving ahead at pace — all to ensure that the co-operative is protected from volatility as much as possible. Thank you to everyone who has made contact to express support for me as your new Chair. I will work hard to provide the leadership and guidance that moves NZPM forward and continues to honour the co-operative ethos and principles important to all of us. I am looking forward to meeting as many of you as possible at the Shareholder Roadshows in June/ July, and the Annual Meeting in August.

CEO update

Despite signs of the challenging economic year ahead, it is pleasing to let you know that the first two months of the new financial year have started well for NZPM with both revenues and profit being solid.

We are seeing the uptake of tradespeople using the pwGO App and pwGO Online platforms steadily increase, with approximately 8% of our revenues now transacted through these mediums.

Users of pwGO are enjoying several benefits that help them significantly improve the efficiency and productivity of running their businesses, which is more important than ever when operating in tighter economic conditions. For example, pwGO Express enabling you to scan QR codes on our product bins in the branch, the information is automatically uploaded to our computer system meaning you don't wait in line for the order to be rekeyed, saving users a huge amount of time and therefore money.

It was great being able to attend the Master Plumbers NZ Plumbing Conference in Christchurch in early May. Over 350 people attended the Plumbing World sponsored awards night on the Friday evening and it was great to see one of our NZPM Shareholders, Devine Plumbing in Napier, take out the Master Plumber of the Year award — well done to Cam and his team.

We also conducted our annual NZPM Managers Conference in May where we communicate the strategy and key initiatives for the forthcoming year, along with recognising great performance at our NZPM Co-operative Awards evening. Four of the notable award winners this year were:

 The Taurus branch of the year for overall best performance (measuring all key metrics) went to Pukekohe branch.

- The DeBernardo Contribution award recognising an individual or teams' outstanding contribution to the Co-operative over many years went to branch manager Brendan Bishop in Levin who has been with Plumbing World for over 25 years.
- Leader of the Year went to Jason Daniel, branch manager in Hamilton for his exceptional leadership over an extended period.
- The Social Responsibility award recognising significant support to our social, environmental and sustainability programme went to the Northern Region who along with our customers raised over \$10k for Big Buddy.

NZPM's 59th Annual Meeting will be taking place in Christchurch on Friday 18th of August.

Along with letting you know how the business performed for the March 2023 year we will also be communicating some of the exciting plans we have for the future and seeking your support to officially change the NZPM Group Limited name to NZPM Co-operative Limited.

NZPM Group tends to reflect a broad operating group of companies and has a very "corporate tone" to it, which we aren't, with only Plumbing World and Metrix actively trading externally. We believe this change of company name better aligns with our co-operative structure and ethos and reflects a simple change to a brand — NZPM Co-operative that is already largely in daily use.

From our perspective the change will be implemented at modest cost, but it does require shareholders to support a special resolution at the Annual Meeting.

Our new Chair, Kathy Meads and I will be conducting a NZPM Shareholder Roadshow in five metropolitan centres during June and July which is a great opportunity for you to meet and catch up with Kathy and I while also hearing how your co-operative is performing. The schedule of the Roadshow is outlined in this edition of Connector and I look forward to seeing as many of you as possible.

Once again, thank you for your continued support of your NZPM Co-operative, Plumbing World and Metrix — it is much appreciated.

- Upgrading or relocating a large number of branches and acquisition of crucial sites at Papanui, Kingsland, and Drury.

- The establishment of a bulk warehouse at Wiri to facilitate efficient nationwide distribution of our own brand and exclusive product.
- Our partnership with Aquasource to enhance our own brand and exclusive product sourcing capabilities.
- Sustainably growing our rebate dividends from operating profits.
- Investing in new technology to provide new services to customers and improve our efficiency.
- Developing and growing the Future Governance programme.

Throughout my extensive involvement in the plumbing industry, I have had the privilege of engaging in governance and other practical areas. Governance, in particular, has been a passion of mine, and the Future Governance programme is a great foundation to identify and nurture new governance talent from our shareholder pool. As our co-operative continues to grow and continues down a path of innovation, it is imperative that we have a capable pool of governors to guide its future.

On a somber note, I was deeply saddened by the passing of our beloved Chair and my dear friend, John DeBernardo. His unwavering dedication to the NZPM Co-operative, its shareholders, and the diligent employees who constitute its backbone will forever be remembered. I extend my heartfelt gratitude to all who have supported me throughout my tenure as a director. I am confident that Kathy will excel in her role as Chair, supported by her fellow directors and the management team.

It has been an incredible experience and I am filled with a profound sense of gratitude and satisfaction for the privilege of being part of the NZPM family. I will cherish the fond memories that have been created over the years.

2023 Future Governance Programme

NZPM Future Governance Programme

Applications are now open for our 2023 NZPM Future Governance Programme.

The NZPM Board welcomes applications for the programme from interested ordinary shareholder members, as we continue to help foster future elected director capability from within our membership. Applications close on 7 July 2023.

The Future Governance Programme runs for an initial period of 12 months from September 2023 to August 2024. The company will make an assessment at the end of this period and consider offering an extension of a further 12 months if the appointee is meeting their participation and development objectives. During their tenure, Future Governors will participate in NZPM Board meetings and receive some Institute of Directors structured governance training, and one-on-one mentoring from an independent professional director.

The objective of the programme is to identify potential future elected directors for the NZPM Board. It is expected that the successful applicants will be shareholders who have indicated a strong desire to be involved in the future governance of the co-operative, and who also demonstrate the core attributes for development and mentoring as a potential future director. The Future Governance Programme is not intended to make appointees 'NZPM board ready', as we don't expect to see that level of competence develop in the time available during the programme term. We strongly encourage our appointees to build their governance expertise and learning with other external appointments so that they can bring a variety of skills and experience to future governance opportunities.

The NZPM Future Governance Programme offers a great opportunity for shareholder members to become involved in the governance aspect of the co-operative by learning more about your Board and how they operate, whilst at the same time receiving professional learning as a company director.

Applicants will be shortlisted and interviewed by a selection panel during July, and the successful candidates will be announced at this year's Annual Meeting in Christchurch in August.
